7.1 President's Report

The President updated Board members on the status of RRC's major projects, including the Skilled Trades and Technology Centre and MotiveLab at the Notre Dame Campus, and the Culinary Research Kitchen and the Innovation Centre in the Exchange District Campus.

P. Vogt informed the Board he will be participating in the upcoming Business/Higher Education Roundtable in Ottawa where postsecondary and business leaders meet with senior federal government officials to discuss the future of work and learning. He will also be travelling with an RRC team to India in October to explore partnership opportunities for the College.

7.2 Employee Member's Report

Board member A. Warren updated the Board on the recent College Council meeting and advised that he will be assuming the position of Vice-President, MGEU (RRC Local) in November. He also invited Board members to visit his Employee Board Member site at www.andrewwarren.ca.

7.3 Vice-President, Academic Report

Vice-President C. Watson informed the Board that RRC has partnered with Lynda.com and all RRC students, staff and leaders now have access to the online learning resource. She also reported on new programming and scholarship opportunities available to Indigenous students and the implementation of a Vitality Index tool for reviewing RRC programs.

In response to an enquiry, C. Watson discussed a pilot program for course-based registration which is a fundamental change from RRC's current program model of a set block of courses all students must complete.

The President congratulated Board member Stu Charles and his wife Heather Charles on being named RRC's 2018 Distinguished Graduates. The couple are both graduates of the Computer Analyst/Programmer program and dedicated College alumni.
