### 1. CALL TO ORDER

With attendance constituting a quorum, the Chair called the meeting to order at 5:10 p.m.

### 3. Presentation – Graduate Satisfaction and Employment Report – 2005/06

Director of Research and Planning A. Blackman provided an overview of the 2005/06 Graduate Satisfaction and Employment Report which is widely distributed throughout the province and sent to high schools, government officials as well as a number provincial and federal education and training agencies. The survey was conducted on students who graduated during 2004/05. Its purpose is to provide an accountability mechanism for the College and identify where programming improvements can be made to address the needs of students and Manitoba's workforce.

Highlighted survey results include:

#### Regular Programs

- 96% of graduates are employed (of those in the workforce)
- 89% are employed full-time
- 86% had an education-employment match
- 93% are very satisfied/satisfied with education
- 94% are employed in Manitoba

### Continuing Education

- 63% made an upward move
- 68% received an increase in pay
- 92% are very satisfied/satisfied with education

The report includes a comparison of Red River College's satisfaction rate with Ontario colleges. At the present time Ontario has a mandatory province-wide reporting system that includes a survey similar to RRC. Board members suggested that the College may wish to expand its comparison to colleges in Saskatchewan and possibly Alberta.

The Board Chair noted the College's very positive student satisfaction results and the high employment rate RRC grads enjoy. He commended the College staff for the good work that is being done to maintain the high level of satisfaction and employment.
