1. CALL TO ORDER

With attendance constituting a quorum, the meeting was called to order at 4:00 p.m.

2. APPROVAL OF AGENDA

3. **BUDGET – 2013/14 APPROVAL**

D. Ready, Vice-President, Finance and Administration provided Board members with an overview of the 2013/14 Budget that is the result of a six-month consultative process. The framework for the process was guided by the 2013/14 Budget Parameters and the Strategic Plan, both approved by the Board.

Board members reviewed the Draft 2013/14 Operating Budget. A discussion was also held regarding a schedule of Strategic Initiatives and New Budget Priorities that identified new expenditures deemed essential to the running of a program or department, critical health and safety issues, or that would significantly enhance program quality.

That the Draft 2013/14 Operating Budget dated June 13, 2013 be approved as presented. – CARRIED

4. RED RIVER COLLEGE LEGISLATION

R. Koslowsky presented a draft submission from the Board to the Minister of Advanced Education and Literacy regarding amending Red River College's legislation. He indicated that in the 20 years since *The Colleges Act* was enacted and RRC became a separate entity from government, it has grown and advanced significantly. As Red River College becomes Manitoba's Polytechnic, new legislation is required that acknowledges the College's unique position in Manitoba's post-secondary environment, as well as allows it to operate with the same autonomy that Manitoba's universities and other public sector organizations have been granted.

Following review and discussion, one change was made to the draft document.
