## 8. PRESENTATION – A. BONHAM, DIRECTOR, LANGUAGE TRAINING CENTRE

Audrey Bonham had been invited to present information to the Board regarding RRC's Language Training Centre (LTC). The President introduced the LTC Director, indicating that the team at the Centre has a national reputation for excellence in language training and is an integral part of the Province's immigration strategy.

A. Bonham informed the Board that the LTC is home to approximately 1,200 students and faculty at 123 Main Street. Its English as an Additional Language (EAL) programs include integration and settlement development, English for specific purposes, and bridging programs. The EAL programs for permanent residents are funded by Labour and Immigration Manitoba through the Manitoba Immigration Integration Program. This level of funding has doubled since 2006 and is continuing to grow. Programs for international students are paid for through individual student subscription.

A. Bonham also discussed the LTC's assessment activities, benchmarking projects and applied research projects. Services available for students at the LTC include work experience placements, counseling, employment services counseling, academic advising and English language assessment and referral.

Board members were advised that one of the challenges facing the LTC is a lack of additional available space at their present location to accommodate the growth being experienced.
