5. Presentation – Applied Research and Commercialization

R. Hoemsen, Director of Applied Research and Commercialization (ARC), provided the Board with an overview of the College's ARC program. He discussed the differentiation between the research cultures of colleges and universities, with college research being applied in nature, more short-term, client-driven, and focused on economic development.

Since the ARC Office was created in 2004 it has helped attract over \$25M in capital investments to the College. Recent applied research accomplishments at RRC include:

- Adoption of an Institutional Strategic Research Plan (framework)
- Awarded a NSERC CCI Technology Access Centre \$1.7M
 - One of only five in Canada (BC, AB, MB, ON & PEI)
- Establishment of an Electric Vehicle Technology & Education Centre with a full-time instructor
- NRC-IRAP Contribution Agreements
 - Digital Technology Adoption Pilot Program
 - Clean Water Technology (Lake Winnipeg focus)
- Research Chair Appointments
 - Industrial Imaging (School of Transportation, Aviation and Manufacturing)
 - Science of Early Childhood Development (School of Health Services and Community Development)
- First patent filing Rapid Prototyping of Composite Tooling
- Paterson GlobalFoods Institute \$2M Western Diversification investment in food technology
- International Agreements Brazil, France and Uruguay

The ARC Director also discussed the Applied Commerce and Management Education program that has provided over 150 students with exposure to or engagement in applied research activities at RRC.

- 93% of graduates are satisfied with their education
- 94% of graduates seeking work found jobs (among the highest in the country)
- 98% of graduates are employed in Manitoba
- the average starting salary has increased by 14% in the past five years to \$39,872

D. Rew added that RRC is ranked first in a comparison with 25 Ontario colleges in five key performance areas – Employment Rate; Student Satisfaction; Graduate Satisfaction; Student Satisfaction with Facilities; and Student Satisfaction with Services.
