# 5. REPORTS

5.1 College President Report

The President advised the Board of a number of recent events that he and others from RRC Polytech participated in. He discussed the regular *Coffee Breaks with the Senior Leadership Team* for staff to share their thoughts, ask questions, and get to know members of the senior management. Other activities he attended included a Celebration of Culture Party hosted by the College's Centre for International Education and Global Partnerships, and a meeting with the Canadian Ambassador to Israel along with the Jewish Federation of Manitoba for a tour of Manitou a bi Bii daziigae followed by a meeting with industry partners.

F. Meier reported that he hosted a Presidential Town Hall on February 9 with over 200 staff watching live to hear him discuss *One Year Since Launching our Strategic Plan: What's Next*?. The townhall was recorded for later viewing by those who could not attend the live session.

Other activities across the institution included *Open Doors* (RRC Polytech's Annual Open House) that resumed in-person attendance after two-years of being held virtually, and a number of industry-student engagement events, including the *Indigenous Student Career Fair* hosted in partnership with the Winnipeg Chamber of Commerce, and the RRC Student Association.

## 5.2 <u>SA President Report</u>

Student Member M. Kaur reported that nominations have closed for the RRCSA's 2023 Executive Election being held March 27 – 29. In person voting will resume this year after a two-year break due to the pandemic. The positions available are SA President and three Vice-Presidents.

Other SA-organized events in February included a 2000s night with up to 200 students attending, a Student Ski Trip to Spring Hill, MB and a *Blind Date with a Book* activity on Valentine's Day.

#### 5.3 Employee Member Report

Employee Member J. Geisel informed the Board that College Council met on February 13. The focus of the meeting was a discussion about the impact on people's work and what the changes might mean for the future regarding the various major changes that have occurred at RRC Polytech this year. These include the Leadership for Academic Schools Renewal, a job reclassification initiative, and implementation of a new Human Resource Information System.
