# **Part-Time Course** Drop/ Withdrawal



## Effective Drop/Withdrawal Date

The effective drop/withdrawal date will be the date the College is informed in writing of the student's intention to drop/withdraw, and will determine any refund eligibility. Conversely, any fees still owed (eg. payment plan balances) must be paid as per the original agreed upon dates and amounts.

### **Course Drop**

Completion of this form is required to drop a course. Students are responsible for informing the College of their intention to drop a course via the methods listed below and by the following deadlines:

Classroom Delivery Courses - partial refunds are available up to the day before the start of the second class. Classroom Delivery Workshops and Seminars - partial refunds are available if request is received a minimum of eight (8) calendar days prior to start date.

Distance Delivery Courses - partial refunds are available if request is made within ten (10) calendar days from the start of course.

### **Course Withdrawal**

Completion of this form is required to withdraw from a course. Students who withdraw from a course after the above noted deadlines are not eligible for a refund. Students doing courses by distance delivery are not eligible to withdraw if they have purchased an extension on their course. The course will appear on the student's transcript with a grade of Voluntary Withdrawal (VW) or Failure (F) as determined by College policy. Students withdrawing at least three (3) weeks prior to the original course end date, who have not written their final exam, will be eligible for a grade of VW. Students withdrawing within three (3) weeks of the course end date will receive a grade of F.
